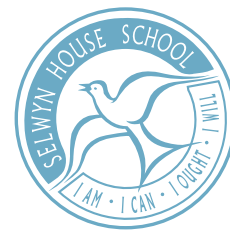


# SELWYN HOUSE SCHOOL

## THE PRINCIPAL'S GRANT



The Principal's Grant is available to students who may not be able to afford a Selwyn House School education without assistance. Recipients of the Grant will receive a \$3,000 subsidy on tuition fees per annum for the duration of their enrolment.

Families can apply for:

- **Principal's Grant – Junior School** – for entry into Year 1 in 2026
- **Principal's Grant – Senior School** – for entry into Year 7 in 2026

- It is a prerequisite that students applying for a Grant complete a Domestic Application form for Enrolment. For families completing the Principal's Grant please use the code: **GRANT25** to remove the application fee, this code is valid until October 17 2025.

- Shortlisted Year 7 students will attend an Experience Day on Thursday 23 October 2025
- All students and their families will attend an interview with the Principal the week commencing Monday 20 October 2025
- Grants will be offered on Thursday 30 October 2025
- Grant acceptance is required by Friday 31 October 2025
